

## DRIVER LICENSE OR ID CARD FACTS:

- Hospital birth certificates are not acceptable
- Church marriage certificates are not acceptable
- Florida does not reciprocate REAL ID requirements from out of state
- Birth Certificates from Puerto Rico must be issued after July 1, 2010
- All Commercial Driver License holders must self-certify in one of four categories as to how they operate a vehicle and submit a valid medical card, if required, for every issuance
- Disabled Veterans must present card or letter from Veteran's Administration stating 100% total and permanent disability to receive a discounted license or ID
- To receive the Veteran designation you must be an honorably discharged US Veteran and provide a copy of your DD-214 or retired military ID card (DD Form 2) or other approved document
- Renewal available up to 18 months before expiration
- Issuance of a Florida driver license or ID card cancels any previous out of state credential
- Basic vision acuity testing required for each original or renewal driver license issuance

- Certified and non-certified Driving Records (transcripts) are available for purchase through our offices. You must be present with your ID to receive a Driving Record.

## PAYMENT OPTIONS

Credentials will have a star.

No additional identity documents needed when RENEWING or REPLACING existing REAL ID driver license or ID card with NO CHANGES.

### REAL ID ADDRESS CHANGE:

Provide proof of new residential address – Bring TWO (no post office boxes) see listing of examples

### REAL ID NAME CHANGE:

Provide proof of name change AND social security card updating – Bring ONE from each section (photocopies are not acceptable)

- Original/Certified Copy of Marriage Certificate
- Original/Certified Copy of Court Order
- Original/Certified Copy of Divorce Decree to restore a previous name (when granted)

AND

- Social Security Card in New Name
- Social Security Letter/Print out with New Name and Number

Please allow 24-48 hours processing time after SSA filing before visiting our office.

## NOT REAL ID COMPLIANT?

### PRIMARY IDENTIFICATION BRING ONE

Photocopies are not acceptable

- Original/Certified U.S. Birth Certificate
- Valid U.S. Passport or Passport Card
- Original Consular Report of Birth Abroad
- Original Certification of Naturalization
- Original Certificate of Citizenship

### MARRIAGE CERTIFICATE(S)/COURT ORDER/DIVORCE DECREE (MUST BE ORIGINAL OR CERTIFIED COPY)

Photocopies are not acceptable

- Marriage certificate(s) needed to link your maiden name to your current name
- Court order is needed if you legally changed your name
- Divorce Decree can be used to restore a previous name (when granted)

**NOTE:** Documents may not be required if presenting US Passport in current name or if multiple marriages apply and current marriage certificate references maiden name.

### PROOF OF SOCIAL SECURITY NUMBER BRING ONE

Photocopies and handwritten forms are not acceptable

- Social Security card
- Social Security letter/print out with entire name and number
- W-2 form with entire name and number
- Paycheck/stub with entire name and number
- 1099 form with entire name and number
- Medicare card with your social security number listed

### PROOF OF RESIDENTIAL ADDRESS BRING TWO

Some examples are:

- Rental/Lease Agreement
- Utility Bill
- Voter Registration Card
- Vehicle/Vessel Registration
- Bank Statement
- Self-Certification Affidavit

**Note:** Documents provided must be two different forms.

### LEARNER PERMIT INFORMATION:

- At least 15 years of age
- Traffic Law Substance Abuse Education course successful completion (may be reciprocated with out of state or country driver license)
- Road Signs and General Knowledge testing successful completion (may be reciprocated with out of state or country driver license)
  - \* Written testing available up to 3:30 p.m. at each office location
- Parental Consent (under 18 only)

Upgrading from Learner License to Class E will require successful completion of Road Skills testing

Road Skills testing available at the North Fort Myers and South Fort Myers Office locations by appointment only
